

## Transferring Funds

### For Citi International Personal Bank clients who hold an Account with Citibank N.A., Jersey Branch.

For maximum flexibility, funds in a number of currencies can be transferred to or from your account in several ways. Citi International Personal Bank will not levy any charges against funds transfers received into your account, however, please note that the Citi IPB Reference Exchange Rate will apply to transactions that require currency conversion(s).

A Citibank Global Transfer (“**CGT**”) allows you to send money instantly between Citibank accounts across the world, transaction fee-free (participating countries only). CGTs can also be made across currencies without charge when the currency of the destination account is the same. Limits may apply. CGTs can be carried out via Citi Online, the Citi Mobile® UK App, or your Relationship Manager.

Another way to transfer money into or out of your Citi International Personal Bank account is through the international funds transfer network, SWIFT. The SWIFT payment method can be used to transfer funds in all of the currencies listed below and overleaf. Charges apply for SWIFT transfers. SWIFT payments can be made via Citi Online or your Relationship Manager.

Single Euro Payments Area (“**SEPA**”) is a payment system designed to make Euro payments to participating countries quickly, safely and without charge. Euro payments by SEPA can be received into your account. However, as Jersey is not a participating SEPA country, you cannot transfer funds from your account using this method.

Faster Payments allows you to make transaction fee-free payments to beneficiaries in the UK with payments credited the same day and usually within a few hours. You can make a Faster Payment online via Citi Online although there are payment limits with this service.

CHAPS is a payment method which enables you to make same day payments to and from bank accounts in the UK, Channel Islands, Isle of Man and Gibraltar. CHAPS payments can be made via your Relationship Manager and are transaction fee-free.

### How to transfer funds into your account

To make sure your funds are transferred quickly and easily into your account, you should provide the following information to the bank sending the money. We will always need to credit the following bank:

<b>Intermediary Bank Name:</b>	Citibank N.A., London Branch
<b>Intermediary Bank SWIFT/BIC:</b>	CITIGB2L
<b>Beneficiary Bank:</b>	Citibank N.A., Jersey Branch
<b>Beneficiary Bank SWIFT/BIC:</b>	CITIGB2LJER
<b>Beneficiary Name:</b>	Your name
<b>Beneficiary Account:</b>	Your IBAN

To obtain your International Bank Account Number (“**IBAN**”) for SWIFT transfers, which is unique for each currency, please log in to Citi Online, check your latest statement, or contact your Relationship Manager. The IBAN for receiving Euros into your account is provided in this leaflet.

For receiving SEPA payments into your account, please refer to the IBAN information under the section ‘**SEPA (€), Faster Payments (€), CHAPS and BACS (€)**’.

The bank sending the money may request the correspondent bank’s details. The correspondent bank’s details are listed below and overleaf and if requested, should be provided to avoid any delay or rejection of the funds transfer.

## How to transfer funds out of your account

When you want to make a payment out of your account you will need to give us certain details about the beneficiary and the beneficiary's account (including the beneficiary's bank). The details we need will depend on the payment type. There are different types of payment which can be used to transfer funds out of your account, and more details about each are set out in the table below.
