3 What will you have to pay us for our services?

Unless otherwise defined, capitalised terms are defined in the Citi International Personal Bank General Terms and Conditions.

Where we provide you with Advisory Services in respect of Funds you will pay for our services in respect of each Fund in which you decide to invest on the basis of an Advisory Fee (comprising an advice fee and a transaction fee). The Advisory Fee will apply if you make an investment in a Fund (whether or not you are investing in accordance with our advice) but where you decide not to make any investment in a Fund, the Advisory Fee will not apply.

Where we provide you with Non-Advisory Services you will pay for our services in respect of each transaction on the basis of a transaction fee. Where we provide you with Non-Advisory Services, we may also in certain circumstances receive payment from issuers, fund(s), managers or distributors relating to your investment, in effecting your investment (see "other benefits we may receive" section).

Irrespective of whether we provide you with Advisory Services or Non-Advisory Services, you will also be required to pay us a global custody fee for the custody of your assets with us.

Advisory Services

Advice fee

Where you receive investment advice from us as part of our Advisory Services in respect of a Fund, you must pay us an advice fee for the advice that you receive, if you decide to invest in the relevant Fund. This fee is payable by you in addition to the amount which is to be invested in the Fund.

The advice fee will be calculated as a percentage of the amount of your investment in the relevant Fund and based on the Citi International Personal Bank Client Segment to which you belong:

Below min balance	2%
Citigold International	1.5%
Citigold Private Client	1%

Transaction fee

Where you receive our Advisory Services in respect of a Fund, there will also be an additional transaction fee of **2%** of the amount of your investment in the relevant Fund, irrespective of the Citi International Personal Bank Client Segment to which you belong.

In relation to investments in money market funds, however, please note that the transaction fee will be 1% (rather than 2%).

Illustration of the calculation of the advice fee and transaction fee

A summary of these charges is set out below. These indicative charges may be subject to change from time to time, or on a case by case basis, in accordance with our internal policies and procedures. Please note that there may be other charges imposed by the product provider or which you have to pay in connection with your investment. Further details are explained in the product's fact sheet, Key Investor Information Document or brochure (where applicable). The following paragraphs only explain the charges you pay to us.

Details about fees we charge for the services we provide in respect of other investment products can be found in our Fee Schedule which will be provided to you separately. Unless otherwise stated, our fees will be calculated in USD and will be converted into and charged in the Denominated Currency of the relevant Account using the Citi IPB Reference Exchange Rate.

Citi International Personal Bank Client Segments

The charges that apply will differ according to the Citi International Personal Bank Client Segment to which you belong. The Citi International Personal Bank Client Segments are tiered according to the balance of your account held with us, as follows:

- **<u>Citigold International</u>**: minimum balance of USD 100,000 (or equivalent) held with Citi International Personal Bank.
- <u>Citigold Private Client</u>: minimum balance of USD 1,000,000 (or equivalent) held with Citi International Personal Bank.

References in this document to "below min balance" refer to clients who have a balance of less than USD 100,000 (or equivalent) held with Citi International Personal Bank.

If you are unsure of the Citi International Personal Bank Client Segment to which you belong, please contact us for further information.

Advisory Services

Advice fee

Where you receive investment advice from us as part of our Advisory Services in respect of a Fund, you must pay us an advice fee for the advice that you receive, if you decide to invest in the relevant Fund. This fee is payable by you in addition to the amount which is to be invested in the Fund.

The advice fee will be calculated as a percentage of the amount of your investment in the relevant Fund and based on the Citi International Personal Bank Client Segment to which you belong:

Below min balance	2%
Citigold International	1.5%
Citigold Private Client	1%

Transaction fee

Where you receive our Advisory Services in respect of a Fund, there will also be an additional transaction fee of **2%** of the amount of your investment in the relevant Fund, irrespective of the Citi International Personal Bank Client Segment to which you belong.

In relation to investments in money market funds, however, please note that the transaction fee will be 1% (rather than 2%).

Illustration of the calculation of the advice fee and transaction fee

If you are a Citigold International client and wish to invest USD 10,000 in a Fund, you will be charged upfront fees of USD 150 (i.e. 1.5% of USD 10,000) as an advice fee and USD 200 (i.e. 2% of USD 10,000) as a transaction fee in addition to your investment in the Fund of USD 10,000. Therefore you will pay USD 350 as an aggregate advice fee and transaction fee, and USD 10,000 will be invested in the Fund.

As you custody your assets with us, you will also be required to pay the global custody fee, as specified below.

Illustration of the calculation of the advice fee and transaction fee (with leverage from Citi International Personal Bank)

In some cases, we may provide you with a loan which you can use together with your own money to invest in a Fund. Where this is the case, the fees for our Advisory Services will be calculated on the total investment amount (meaning your own investment money plus any loan we have provided to you for this purpose).

By way of example -

If you are a Citigold International client and have USD 200,000 to invest and obtain a loan of USD 150,000 to invest, your total investment amount will be USD 350,000. Where you use our Advisory Services, you will be charged upfront fees of USD 5,250 (i.e. 1.5% of USD 350,000) as an advice fee and USD 7,000 (i.e. 2% of USD 350,000) as a transaction fee in addition to your investment in the Fund of USD 350,000. Therefore you will pay USD 12,250 as an aggregate advice fee and transaction fee and USD 350,000 will be invested in the Fund.

As you custody your assets with us, you will also be required to pay the global custody fee, as specified below.

Global custody fee

The global custody fee of **0.5%** covers the provision of safekeeping services, settlement services and the management of corporate actions related to those securities held in your account at Citi International Personal Bank.

Non-Advisory Services

Transaction fee

The transaction fee will be calculated at a rate of **2%** of the amount of your investment in the relevant Fund irrespective of the Citi International Personal Bank Client Segment to which you belong.

In relation to investments in money market funds, however, please note that the transaction fee will be 1% (rather than 2%).

Illustration of the Calculation of the Transaction Fee

If you invest USD 100,000 in a Fund using our Non-Advisory Services, we will charge you a transaction fee of 2%, which in this case would be USD 2,000.

As you custody your assets with us, you will also be required to pay the global custody fee, as specified below.

Illustration of the calculation of the transaction fee (with leverage from Citi International Personal Bank)

In some cases, we may provide you with a loan which you can use together with your own money to invest in a Fund. Where this is the case, the fees for our Non-Advisory Services will be calculated on the total investment amount (meaning your own investment money plus any loan we have provided to you for this purpose).

By way of example -

If you are a Citigold International client and have USD 200,000 to invest and obtain a loan of USD 150,000 to invest, your total investment amount will be USD 350,000. Where you use our Non-Advisory Services, you will be charged a transaction fee of USD 7,000 (i.e. 2% of USD 350,000) in addition to your investment in the Fund of USD 350,000.

As you custody your assets with us, you will also be required to pay the global custody fee, as specified below.

Global custody fee

The global custody fee of **0.5%** covers the provision of safekeeping services, settlement services and the management of corporate actions related to those securities held in your account at Citi International Personal Bank.

The global custody fee will be calculated daily (as a pro rata proportion of the annual fee) on the value of the relevant assets in your account at the end of each business day, and charged to your account in arrears at the end of each calendar month.

Your payment options

We will discuss your payment options with you and answer any questions you have. We will not charge you until we have agreed with you how we are to be paid and the amount.

Settling your adviser charge through a single payment

All fees payable will be payable to us upfront as a one-off payment (except for the global custody fee, in relation to which please see below) and will be payable in addition to your investment amount. All upfront fees will be payable to us at the time that you place a transaction order.

Global custody fee: Global custody fees will be calculated monthly on the basis described in the "Global custody fee" sections of this document and debited from your Account with us at the end of each calendar month.

Please note that there may be other charges imposed by the product provider or which you have to pay in connection with your investment. Further details are explained in the product's fact sheet, Key Investor Information Document or brochure (where applicable).

Other benefits we may receive

In addition, subject always to the next sentence, we may in certain circumstances receive payment from issuers, fund(s), managers or distributors relating to your investment, in effecting your investment. Where we provide you with Advisory Services (or any related services) in relation to an investment, neither we nor any affiliated company in the Citi group of companies will solicit or accept any fees, commissions or other non-monetary benefits from (or share commission with) any affiliated company in the Citi group of companies or third parties, except in limited circumstances permitted under applicable regulatory requirements. These include circumstances in which we receive trail commissions in relation to certain investments made prior to 31 December 2012.

Further information on the above arrangements is available on request, including but not limited to information as to the amount or basis of calculation of any commission or monetary or non-monetary benefits we give to or receive from third parties with respect to introductions or the provision of ancillary products or services.

6 Are we covered by the Jersey Bank Depositors Compensation Scheme (DCS)?

We are covered by the DCS. The Scheme offers protection for eligible deposits up to £50,000 but only applies in respect of "eligible depositors", which includes individual natural persons, but does not, for example, include corporate clients or trustees. The Scheme only applies in respect of "eligible deposits" which means cash deposits held in a bank in Jersey, such as Citibank N.A., Jersey Branch, but will not, for example, include any deposits held in banks outside Jersey or any investments held in Jersey or elsewhere. The maximum total amount of compensation is capped at £100,000,000 in any 5 year period.
