Limited Period Offer Terms and Conditions

1. AMF Spend Based Reversal from Second Year

- a. The 'AMF Spend Based Reversal from Second Year' offer is applicable only on the Citi Life Platinum and Mastercard Credit Card (hereinafter individually referred to as the "Card").
