#### 1. INTRODUCTION

This environmental, social and governance ("**ESG**") disclosure ("**Disclosure**") has been prepared by Citigroup Global Markets Limited ("**Citi**") as the administrator of the Citi US Large Cap ESG Series 1 Indices Family ("**Indices**"). It is intended to meet the requirements of the United Kingdom Benchmarks Regulation.

The "United Kingdom Benchmarks Regulation" is the European Benchmarks Regulation, as it forms part of the domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (the "Act") and as amended pursuant to the Benchmarks (Amendment and Transitional Provision) (EU Exit) Regulations 2019 (SI 2019 No. 657), and as may be further amended.

The "European Benchmarks Regulation" is Regulation EU 2016/1011 of the European Parliament and of the Council of 8 June 2016 on indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds and amending Directives 2008/48/EC and 2014/17/EC and Regulation (EU) No 596/2014.

This Disclosure is also intended to meet the requirements of the European Commission Delegated Regulation (EU) 2020/1816, as it forms part of the domestic law of the United Kingdom by virtue of the Act, and as may be amended.

Any reference in this Disclosure to EU legislation shall be to such legislation as it forms part of the domestic law of the United Kingdom by virtue of the Act.

ESG Book is wholly independent of Citi and provides ESG Scores to a number of financial institutions and other organizations, including Citi.

The Indices provide notional exposure to the performance of a number of equities (shares), on the basis of the ESG Score that is measured for each company whose shares are reference by the Indices.

By way of brief summary, the ESG Score is intended to quantify a company's performance on a range of environmental, social and governance (ESG) metrics. A company's ESG Score aggregates the company's performance in 26 (formerly 22) different ESG-related areas into a single score. The Indices use this single ESG Score for each company. ESG Book measures ESG Scores for publicly-listed companies in both developed and emerging markets. To measure ESG Scores, ESG Book uses both algorithmic processes that it has developed and underlying data provided to it by other organizations. The underlying data are not provided to Citi.
