# on the General Data Protection Regulation related amendment of general contractual conditions and other modification

Dear Client!

Citibank Europe plc Hungarian Branch Office, acting in the name and on behalf of Citibank Europe plc hereby informs you that the Bank amends its general contractual conditions below and General Terms of Contract of Corporate Bank Cards with the effective date of May 25, 2018:

- General Business Conditions of Corporate Services
- Confidentiality and Data Privacy Conditions (for client with MAST Framework Agreement)

The reason for the modifications is that General Data Protection Regulation (GDPR) is to be entered into force as of May 25, 2018, which supersedes national legislation and harmonizes the data privacy laws across EU countries.

## I. General Business Conditions of Corporate Services of the Bank are changing:

- Definitions: Introduction of new GDPR related definitions,
- supplement of point 3 with Privacy Policy (3.2 3.10),
- point 3: related to the Central Credit Information System have been moved to Annex VIII. under point 32,
- 40.1 sub-point for Safety Events has been added to point 40.

### II. Confidentiality and Data Privacy Conditions dokumentum alábbi pontjai változnak:

- supplement and modifying of Point 1 Introduction,
- supplement of sub-point 5.2 Other disclosures
- modifying of point 6 Retention and deletion
- modification of point 7. Data Privacy and 7.2 Compliance with GDPR/Equivalent Laws and 7.6. Legal basis for Processing sub-points were inserted
- point 9 Data Protection is cancelled
- Definition: Introduction of new GDPR related definitions, definition of Trade Transaction is cancelled

## III. General Terms of Contract of Corporate Bank Cards is changing in:

- Last sentence of 8.7 point is cancelled
- 8.9 point is cancelled
- Supplement and cancellation in Chapter X. Data protection, data management

You are deemed to have accepted the changes if you do not notify us that you do not accept them before the date of their entry into force. You have the right to terminate the framework contract and the MasterCard Corporate Card Contract in written - immediately and free of costs, fees and other payment obligations - before the date of coming into force.
