Citibank will advise the recipients set out in Annexure "A" hereto on the activation procedures to facilitate the secure delivery of Statements electronically, which procedures will include, without limitation, the security regarding password protected attachments to emails as well as activation and ongoing use of the password requirements and which procedures will be supplied to the Customer.
- 3. The Customer shall notify Citibank in writing of any changes to the information set out in Annexure "A" hereto from time to time. Upon written acknowledgment by Citibank of receipt of such written notice, Citibank shall send Statements in respect of the accounts to the persons so designated by the Customer.
