INFORMATION CONCERNING A PETITION FOR HEARING

Under the Debt Collection Act of 1982, you have the right to request a hearing for the following reasons: to contest (1) the validity of the debt; (2) the amount of the debt; and/or (3) the terms of the proposed offset schedule. A hearing request, for the purpose of salary offset, is not a formal, in-person hearing of the parties involved, but is a written review of the records pertaining to the case. It is a paper hearing to validate the debt and ensure that you received due process in regard to the debt collection procedures. It is not an appeal to the reason for the debt, or a means to correct an injustice.

In order to request a hearing you must submit the enclosed Petition for Hearing and the supporting documentation identified on the form to the address above. You may include any other documentation that you feel will benefit your case. The Hearings Division will consider any documents submitted by you, or those that can be obtained from the Department of Defense and the Travel Card Agency.

If your Petition for Hearing is timely, it will suspend collection proceedings, to include the accrual of interest, penalties, and administrative charges until the hearing official issues a decision. A petition that is submitted late does not guarantee that the debt collection will be suspended; however, if the hearing determines that the debt in not valid, any money collected will be refunded to you.

In very rare instances will an oral hearing be granted. The Department of Defense will determine if your case warrants a paper, or an oral hearing. Oral hearings are considered when there is a question of credibility or veracity, and the hearing can not be fully conducted, or the indebtedness resolved by review of the documentary evidence only. You will be given sufficient time to prepare in the event an oral hearing is warranted.
